Chief Stange – Read aloud the Budget Message for Fiscal Year 2022-2023.

Chief Stange – Asked if there were any questions on these. No questions at this time.

Chief Stange – Presenting the Budget - he stated he would be reviewing the line items that had significant changes but to feel free to ask any questions on any of the line items.

Chairperson Ken Coffman – Asked if there were any questions.

EQUIPMENT RESERVE FUND: E-7055 – E-7088

Chief Stange- Chief Stange stated ambulance purchase budgeted for in this year as well for ability to purchase when available. Also making sure that the passenger cars are up to date. No other major purchases in the next couple of years.

GRANT FUND

- G-7001 FEMA GRANT Chief Stange stated that the district applied for additional staffing through the SAFER Grant for adequate fire and emergency response.
- G-7007 SDAO GRANT SDAO provides 50/50 matching grant to hire interns to assist on special projects.
- G-7009 TRIBAL GRANT Chief Stange stated Josh Dalrynple is working with Monmouth Police, Independence Police, and Central School District for a grant on AED's through the Spirit Mountain Community Fund. This is an attempt to add/replace 37 AED's and one trainer in the community.

MARK AND MILDRED LAUDAHL FUND

Laudahl Fund Resources and Expenditures – Chief Stange stated this fund is for Memorial and Façade improvement. Having a hardscaped area to put plaques to honor people who have served. Also to make a covering for the front awning of Station 90.

DEBT SERVICE

No debt at this time.

Chairperson Coffman – Asked if there were any questions. No questions at this time.

Chairperson Coffman – Asked if anyone had signed the list for public comments. No one had signed the request form to speak.

Chairperson Coffman – Asked if the Committee had any questions.

Mike Lippsmeyer – Asked about having discussed previously about students upstairs. How many students can you fit up there, and if you don't have that many students does it make living arrangements easier.

Chief Stange – Stated that yes it will especially with the grant however not able to housing night residents. There are three dorm rooms left, the rest are already shared as much as is safely possible. Not comfortable having a program where there can't be separate dorm rooms for female, and male.

Cord Von Derahe – Asked will there be a gap in GEMT money with the state signing this contract in the eleventh hour?

Chief Stange – Stated no it should catch up. From what was read it should pay for all of 2022 since it is being signed in 2022.

Cord Von Derahe – Asked is the expense (GEMT) split up evenly or percentage wise. Are we being held at the same rate as a county that runs a lot more calls?

Chief Stange – Stated that it will be granted by percentage of calls.

Chairperson Coffman – Asked about the Equipment Reserve Fund chart, and wondering if the yearly funds have been preplanned for with financial means.

Chief Stange – Stated the items that are not fire apparatus, we can maintain this fund throughout the year so that when the time comes to replace equipment 2029-30B will be paid for and we won't have a bond to pay for.

Cord Von Derahe – Asked if Chief Stange had conversations with the cities discussing the Urban Development Fund on whether or not it will grow or expand, if those districts get bigger.

Chief Stange – Stated has had conversations with the cities in hopes to reset the increment of increase on property assessment.

Cord Von Derahe – Asked if we are to get the SAFER Grant, are the expenses for hiring (PPE, uniforms, etc.) included in the Budget for 2022/2023.

Chief Stange – Stated that the biggest expense is PPE and training time. Hiring cost for background checks, medical assessments, psychological evaluations are included in the grant.

Chairperson Coffman – Asked are there itemized or additional costs for employees more than what the grant can offer?

Chief Stange – Stated the PPE would be about \$3,000 per employee once they get turnouts and all their gear. There have also been more funds budgeted for in the uniforms line item. It would be possible

Mike Lippsmever read the motion.

Mike Lippsmeyer - I move that the Budget Committee of Polk County Fire District No.1 approve the Budget for the 2022-23 Fiscal Year in the amount of \$7,409,956.

I move that the Budget Committee of Polk County Fire District No.1 approve property taxes for the 2022-23 Fiscal Year at the rate of 1.5038 per \$1,000 of Assessed Value for the permanent rate, \$0.19 per \$1,000 of assessed value for the Local Option Tax Levy rate, and the amount of \$170,000 for the General Obligation Bond levy.

Bob McMillian – Second.

Chairperson Coffman - All in favor – none opposed – 2022-23 FY Budget is approved.
